Fees are nonrefundable, but it is possible to transfer the application to a third party which will ensure his own enrolment.

Veterinary Conditions:

The dog must be in good clinical health,

The dog must have the record of vaccinations with proof of vaccination against rabies.

Dogs which have not passed the veterinary control in due time, must not participate in the event.

Further terms:

- To be able to be admitted for tests or championships, identification of the dog is possible either by tattoo or chip number.
- To be able to be admitted for TRIAL competition it is necessary to produce a certificate of completion of exams of the required grade.
- All other conditions and terms are conducted through the FCI guidelines and regulations.

The dog handler confirms that:

- he is aware of the Czech law of animal protection.
- he is lawfully responsible for any harm or damage caused by his dog. (Any damage will be reported and noted down by the organizer).
- In the case of any founded damage to animals this will be settled with the owner's agreement.
- he agrees with the publication of the above mentioned information about himself or his dog in the event of results.

The number of participants is limited. Czech Briard Club members have the option of preferential registration.

Acceptance of the application will be decided by the organizer.

Changes in propositions and referee delegation is reserved.

In case the event is annulled or if an application form is refused, the organizer will inform participants at least five days before the intended date of the event.

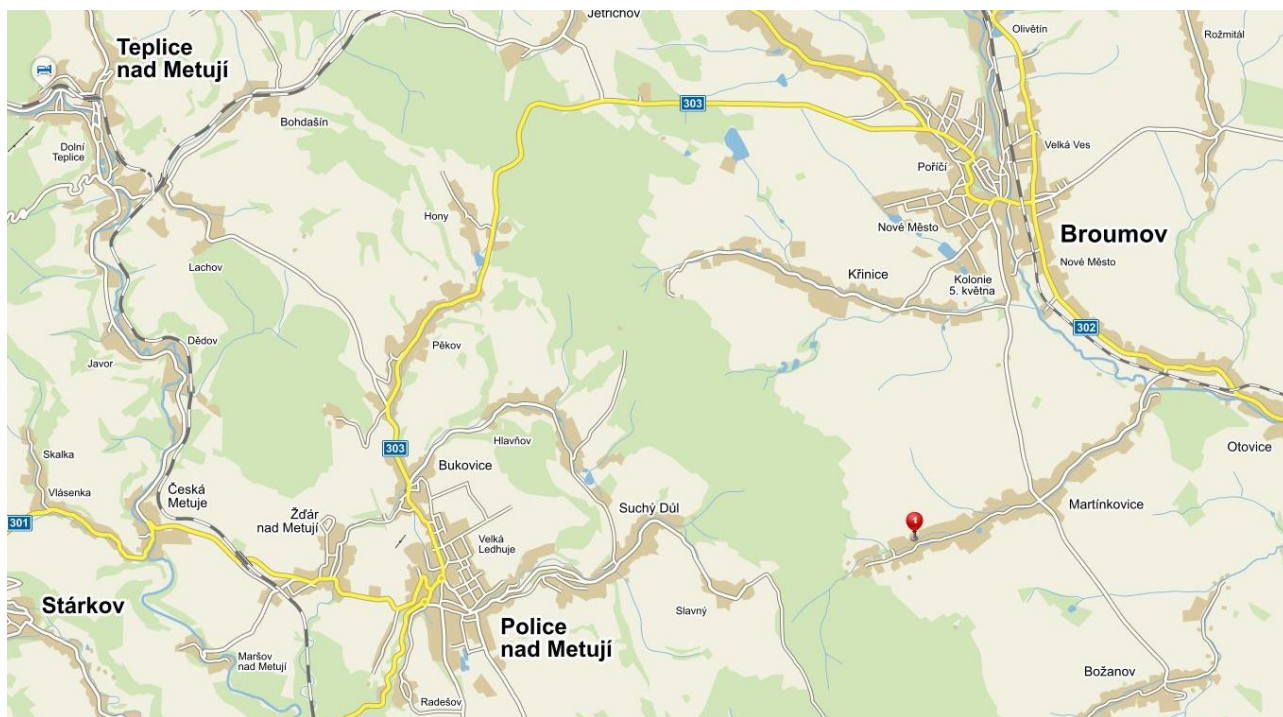


FACILITIES AND ACCOMMODATION:
